If this authorization is granted, I/We agree to the following conditions:

1. The Board of Sharon Township Trustees grants to utility companies, their successors and assigns, subject to the following regulations and so far as said Board has authority to do so, permission to install transmission lines in and across public roads and highways under the jurisdiction of this Board, as shown on plans hereinafter provided, but subject however to the laws of Ohio governing the location, construction, removal and/or removal and relocation of such transmission lines and all lawful orders issued by the Board of Trustees or other public officers having authority.
2. Application for authorization to install utilities shall be made to and approved by the Sharon Township Road Department and/or Franklin County Engineer upon the application form attached hereto and by reference made part hereof, and the conditions thereon shall be a part of these regulations as if completely rewritten herein.
3. Said transmission lines shall be installed in and/or across the roads named in the application form and only in the locations and at the grades established and delineated upon the drawing attached to the application form and as approved by the Road Department and/or County Engineer.
4. Such location shall be changed as may be directed by the Board of Trustees and its successors in authority when such changes or relocations are necessary for the convenience of the public, or in connection with, or in contemplation of the construction, reconstruction, improvement, maintenance and repair of said roads, or

any other public ways or any other public improvement. All expenses of such change shall be paid by the company, or in the event of the failure to make such changes after 30 days written notice to do so. The Board of Sharon Township or other public authority may make such changes, all cost and expenses of which shall be paid by the Company.

5. The said utility companies shall at all times and at all places maintain their transmission lines in a safe and proper manner and shall promptly repair all damages resulting from time to time to said roads on account of the use and occupancy of said roads and in the event of failure to do so after 30 days written notice shall promptly pay to the Township and other public authority all cost and expenses which may expended in repairing such damages.
6. The grant herein made shall not be exclusive and nothing herein shall be construed to prevent the Board of Trustees or other public authority from granting the privilege for like purposes herein granted to any other person, firm or corporation hereafter making application therefor.
7. Upon failure of the utility company to carry out and comply with and or all of the provisions of the foregoing grant on their part to be performed or complied with, then this grant shall be null and void.
8. All provisions and regulation herein contained shall be binding upon the utility companies and the transfer or assignment of any of the rights and privileges hereby granted shall not release or relieve the companies therefrom.

The utility companies or their contractors shall not begin construction (boring, open cut, or work of any nature) of their project within the highway right of way without first securing a written permit from Sharon Township, at least forty eight (48) hours prior to starting work. This permission **Does Not** constitute a permit.
