## Minutes from March 20, 2024

Oberle moved to approve the March 20, 2024 minutes. Kunze seconded the motion. Motion carried unanimously. Palmer abstained from voting as he was not in attendance at the meeting.

# Authority for Deer Feeding Resolution--Update

Oberle explained that he had a discussion with township legal counsel about whether Sharon Township can adopt a prohibition against feeding deer. Legal counsel explained that the Township does not have such authority.

## New Business:

# Columbus Class B Biosolids Management Program/Mt. Air

Palmer introduced the topic by summarizing the information as it was being learned. Palmer invited Kunze to provide information Kunze had learned.

Kunze noted the heavy truck traffic in the neighborhood and the discussions with neighbors in Mt. Air. Kunze explained that she then learned that the Class B permit had been issued.

Kunze explained that she contacted the Ohio EPA and reviewed various documents and laws. Kunze discussed that she, and many of her neighbors have noticed unpleasant odors.

Kunze noted that the Sharon Township roads in the area are not built to hold the weight of the tankers.

Residents expressed significant concern about the proximity of the risk and the unknown nature of the risk.

Kunze noted that she had discussed the matter with State Senator Kunze.

Kunze did explain to the residents that the three trustees may not discuss the matters outside of a

Palmer noted that the City of Columbus has contracted with Deer Valley to dispose of the waste. Palmer asked Supt. Kayati if anybody had reached out previously about using the roads. Kayati confirmed that no such communication occurred.

Palmer clarified that the concern was with the weight and the width of the road.

Oberle asked the property owner to explain the need for this permit.

Mr. Hadden, the property owner, explained that there is an ongoing need for farms to fertilize. Hadden claimed that the product is a natural, organic product. Hadden explained that if the land is not used for farming, the property taxes will increase. Hadden noted that the farm has used this product for decades.

Oberle noted that the farm is surrounded by residential properties. Oberle asked if there were less offensive smells. Hadden stated that all applications have smells.

Oberle noted that the Ohio Administrative Code provisions in this area are the problem. Oberle expressed his frustration that the notification is permitted by email and not regular mail on a topic of this importance.

A resident asked if the applications would take place in the future. Hadden noted that he intended to do this again in the future.

A resident asked if the Franklin County Board of Health has been notified about this. Kunze noted that a resident had contacted the Board of Health and will report back.

Residents noted that California and Maine have banned the application in question. The resident asked if Hadden would commit to better communications in the future so that residents do not have the issue sprung on them again in the future.

A resident asked Hadden to explain the process for the application. Hadden described the process from analysis through application of the material.

A resident asked what is known about viruses and pathogens potentially included in the waste in the application. Hadden admitted that he was not aware of the answers. Hadden did note that the City of Columbus may have these answers.

A resident asked about the notification procedures and why neighbors were not made aware of the application. Hadden did not have answers about the requirements.

A resident asked about the possibility of making children and neighbors aware of the application. Hadden expressed support for this approach.

A resident asked if Aqua was aware of the waste application. It was noted that Aqua was not on the distribution list. Kunze stated that she would follow up with Aqua.

# Rosslyn/Kanawha/Westview Sanitary Sewer--Update:

Kayati updated the project and noted there are many water main breaks. The age of the pipes and infrastructure is the cause of the problems and is compounded by the soil composition. Kayati expressed concern with the methods used to repair the roads damaged during the process. The difficulties are going to delay the progress substantially.

Oberle asked Kayati about the responsible party for replacing the water lines. Oberle noted that the sanitary engineer maintains all of the contracts. Oberle is going to investigate the matter.

Oberle asked if the contractor is responsible for repairing the roads to current condition. Kayati noted that it is up to Franklin County to enforce that matter.

Oberle noted that the cemetery has a capital request into the State of Ohio.
